1. MISSION OF THE STUDY PROGRAM

The mission aims to train and develop the skills of designing and implementing interventions in the social field, research, methodological, evaluative, communication, identification and resolution of conflicts, which are necessary for the specialist in social assistance services.

The SAS study program has assumed the mission of professional training and integrated scientific research the field of social assistance.

2. OBJECTIVES OF THE STUDY PROGRAM

The objectives of the SAS study program, through the curricula it proposes, are to specialize in the specific issues of the field, which is approached in the context of knowing the concepts related to the institutions of the European Union and understanding the aspects generated by the role that the policies of the European Union have in the development and implementation of the European social model. The emphasis is placed on the process of training and preparation in order to know and understand the social protection system, sectoral social policies in their dynamics, by reporting to the globalization process. The master's program presents social assistance services and social policies in relation to the analysis of concrete social problems, in order to facilitate the understanding of the structure and functions of the social protection system and the distribution of responsibilities on the central-local axis.

3. COMPETENCES ACQUIRED THROUGH THE STUDY PROGRAM

Identification, information collection, documentation, evaluation and recording of information, analysis, assessment and specific interventions to reduce social risks at the individual, family, group, community and societal levels, with the aim of understanding and using the value system specific to the field of social assistance in the intervention activities carried out;

- C4. Consulting in accessing community resources for excluded individuals and social groups or those at risk of social exclusion (institutions, services, benefits), applying consulting for efficient management in the field of social assistance services;
- C5. Counseling and other specialized intervention methods provided in the family or institutional environment (hospitals, schools, prisons, anti-drug centers, specialized social assistance institutions, etc.) in compliance with the values and principles of the specifics of social assistance, formulating solutions and developing strategies for a modern approach to problematic risk situations for risk categories;
- C6. Communication and professional relationship with beneficiaries and other social actors involved, identifying the specific needs of target groups and developing a sustainable relationship with them through an analysis and efficient use of communication and professional relationship with them.

8. CONDITIONS FOR ENROLLMENT IN THE NEXT STUDY YEAR. CONDITIONS FOR PROMOTION OF A YEAR OF STUDY. CONDITIONS FOR RETURN

The conditions for enrolling in the next academic year, the conditions for promotion and those for returning are included in the ECTS Regulation and in the Procedure for organizing teaching activities and grading students.

In order to move to the next academic year, students must obtain a minimum number of credits, as follows:

- a) To move from the first year of studies to the second year, the student must obtain a minimum of 30 credits;
- b) To move from the second year to the third year, the student must accumulate at the end of the second year of studies a minimum of 90 credits obtained in the first and second years in total;
- c) To move from the third year to the fourth year, the student must accumulate at the end of the third year of studies a minimum of 150 credits obtained in the first, second and third years in total;
- d) In order to be able to register for the bachelor's degree exam, the student must obtain a minimum of 240 credits (minimum 60 credits from each academic year);
- e) To be considered promoted, a student must be a full-time student, meaning that he/she must obtain all the study credits provided for in the curriculum for the respective year of study and obtain a passing grade or grade in the subjects that are not provided with credits;

Students who do not meet the minimum criteria provided for in paragraph 1 letters a-c. will be expelled at the end of the respective academic year. These students will be able to re-enroll at the beginning of the following academic year in the same academic year from which they were expelled

Students who during an academic year (2 semesters of the same academic year) do not accumulate the minimum number of credits, established by the Faculty Council necessary for the student to move from one academic year to the next, will be declared deferred and will be recorded in the enrollment register as "deferred to obtain all the credits for the respective year(s) of study". The deferral of a year of study can be granted for a maximum of 3 academic years for the entire period of study. The study of the failed subjects is resumed, with the entire teaching activity for them being resumed.

The student who, at the end of his studies, after completing the number of semesters (years of study) provided for in the curriculum for the duration of the studies, has not fully completed his school obligations and has a maximum of five arrears in the last four semesters, may request an extension of his schooling (with a fee) by 1 - 2 semesters to make up the arrears of study subjects.

9. THE DISSERTATION EXAM

The conditions for taking the dissertation examination are contained in the Methodology for the organization and conduct of final examinations.
