It is possible that certain changes or corrections may be requested based on the evaluation results.

Selected papers presented at the conference will be published in a Special Issue of the Journal of Financial Studies, edited by the Institute of Financial Studies.

The Conference Book of Abstracts will include the abstracts of the remaining papers.
